

**San Francisco Randonneurs 2010 Brevet Series
Rider Release Form and Refund Policy**

I, _____, voluntarily apply to participate in the 2010 San Francisco Randonneurs Brevet Series. I have read the ride descriptions and the rules for participation in the 2010 Brevet Series from the brochure and/or internet web site. I agree to abide by all of the rules and policies set forth in the official brochure and I warrant that to the best of my knowledge, I am competent to ride safely, that my bicycle and equipment are in safe condition, and that I have no disability that would impair my ability to complete the 2010 San Francisco Randonneurs Brevet Series safely. I recognize and accept all anticipated and unanticipated risks and hazards of participating in a physically challenging bicycle tour involving other cyclists of varying levels of cycling skill and experience on narrow winding roads and facilities that will be open to normal traffic and open to the public during this event during wide ranging weather conditions. If at any time I believe conditions to be unsafe, I will immediately discontinue further participation in the event. I understand that the San Francisco Randonneurs makes no claim as to the safety of this route or the competence of other participants or volunteers. I will wear an ANSI-approved helmet while riding in the 2010 San Francisco Randonneurs Brevet Series, and I assume all responsibility for selecting a helmet that fits me properly and that can protect me against head injury. I agree that the San Francisco Randonneurs may disqualify me from further participation in the SF Randonneurs Brevet Series if I fail to adhere to the rules and conditions in the Brevet Series brochure and this agreement, or fail to follow directions given by SF Randonneurs Brevet Series officials, or if I fail to obey applicable laws. I will not hold the San Francisco Randonneurs, the League of American Bicyclists, Randonneurs USA, the National Park Service or any of the persons or entities mentioned below responsible for any consequences of their failure to detect and warn riders of known hazards or to enforce any rule or condition of participation. In consideration of the acceptance of this application and of my being permitted to participate in the 2010 San Francisco Randonneurs Brevet Series, I, for myself, my heirs, successors, assigns, and personal representatives, waive, release, and discharge all claims that I have, or that may accrue to me directly or indirectly as a result of my participation in the 2010 San Francisco Randonneurs Brevet Series. This agreement applies to claims for personal injuries, including death or permanent disability, and property damage. This agreement is intended to release, in advance, the San Francisco Randonneurs, their officers, directors, and sponsors, and any volunteers, employees, or agents involved in organizing or putting on the 2010 San Francisco Randonneurs Brevet Series, as well as any private landowners and government entities whose property or jurisdiction is involved in the 2010 San Francisco Randonneurs Brevet Series. I also agree that this agreement applies to claims arising out of the carelessness or negligence of the persons and entities mentioned above, and specifically includes any unknown and unanticipated claims that, if known or anticipated at the time that I sign this agreement and release, would make me less willing to sign this agreement, and that might otherwise be protected under Section 1542 of the California Civil Code. San Francisco Randonneurs, the Regional Brevet Administrator or the Regional Brevet Administrator's designate reserves the right to refuse entry to anyone.

Refund Policy

The will be no refunds made for entrants who fail to attend the event. Other situations will be evaluated on a case by case basis. Refunds shall be subject to the following conditions: [1] A \$3.00 deduction will be made from your prepaid entry fees. [2] Each registered rider MUST SUBMIT A WRITTEN OR E-MAILED REQUEST for a refund within two weeks after the event for which you are requesting a refund. Refund requests are to be sent to either of the addresses at the end application page of this document.
